

Pursuant to the authority conferred by Section 183 of The Municipalities Act, the Town/Community Council of Marystown has made the following regulations

R E G U L A T I O N S

1. These regulations may be cited as the Town of Marystown (Solid Waste Disposal) Regulations, 1988
2. In these regulations unless the context otherwise requires:
  - (a) "Act" means the Municipalities Act.
  - (b) "Collector" means any person appointed as such by Council.
  - (c) "Council" means the Town/Community Council of Marystown.
  - (d) "Garbage" means every solid waste accumulation of animal, fruit, or vegetable matter that attends the preparation, use, cooking, dealing in or storage of meat, fish, fowl, fruit, or vegetables, and including tin cans, bottles and similar food containers.
  - (e) "Municipality" means the Town/Community of Marystown.
  - (f) "Nuisance" means anything or any condition of things which is or may become injurious or dangerous to health or which may hinder in any manner the supervision of disease.
  - (g) "Owner" includes agent, tenant or occupant.
  - (h) "Place of Business" means any business house, premises, etc. from which the collector does not collect.
  - (i) "Refuse" means all other miscellaneous solid waste materials not specifically defined as garbage.
3. No person shall create, permit or maintain a nuisance.

4. No person or place of business shall deposit, throw, sweep or place any garbage upon any street, road, lane, drain, public place or private property within the Municipality unless the same is enclosed in a regular garbage container provided with handles and a cover, or in properly secured plastic bags, or properly secured for easy handling.
5. Every person being the owner of a building or buildings and premises within the Municipality shall provide approved containers as mentioned in the preceding regulation for the use of such building or buildings and premises for the reception of garbage, and all garbage from such building or buildings and premises shall be placed in such containers, or in properly secured garbage bags, or properly secured for easy handling.
6. Garbage containers shall be kept covered and in a sanitary condition at all times.
7. All garbage and refuse shall be disposed of at intervals not exceeding one week in any of the following manners:
  - (a) By placing for collection by Council; or
  - (b) By delivery to the Municipal disposal site at a time or times, designated by Council; or
  - (c) By burning or burial under and in accordance with a permit in writing from Council,except that garden waste and broken or discarded household furniture or furnishing may, with the approval of Council, be retained and placed for collection by Council during the period designated as "Clean-up Week".

8. All garbage containers shall be removed by the owner of every building as soon as possible after garbage collection.
9. No person shall place in any container, garbage or refuse intended for removal by Council, the weight of which, together with that of the container will exceed 34 kg (75 lbs.).
10. Every box, garbage bag or other such receptacle containing refuse intended for removal by Council shall be packaged or tied in such a manner as to in no way hinder or impede such removal.
11. Garbage or refuse left by any builder or contractor, or owner upon any street, road, lane, drain, public or private property outside of a building or buildings within the Municipality following the construction, alteration or repair of such building or buildings, shall be removed by the builder, contractor, or owner, as promptly as possible.
12. No person or place of business shall place or cause to be placed any garbage or refuse on the Municipal disposal site except at a time or times designated by Council.
13. No person, other than the Collector, authorized for that purpose, shall pick over, remove, disturb or otherwise interfere with any garbage or refuse placed for removal by Council whether or not it is enclosed in receptacles or containers.
14. No person or place of business shall enter upon or remove any garbage or refuse from the Municipal disposal site unless authorized to do so by Council.

15. When trees are cut, for any purpose, on any land, whether private or otherwise, within the Municipality, all boughs, limbs and treetops constitute a fire hazard and shall either be removed from the area forthwith or piled for burning in accordance with a permit which may be issued by the Department of Forest Resources and Lands, or other authorized authority.
16. At any reasonable time, Council may make a thorough inspection of all public and private property within the Municipality for the purpose of enforcing these regulations.
17. Pursuant to Section <sup>418</sup>443 of the Act, every person who contravenes or fails to comply with any of the provisions of these regulations is guilty of an offence and liable on summary conviction to a fine not exceeding One Thousand Dollars (\$1,000.00) or in default of payment to a period of imprisonment not exceeding ninety (90) days or to both such fine and period of imprisonment.
18. These regulations were adopted by resolution of council at a meeting held on the 17<sup>th</sup> day of *MAY* 1988, and will come into effect on the 18<sup>th</sup> day of *MAY* 1988.
19. All previously adopted (Solid Waste Disposal) regulations for the Municipality are hereby repealed.
