### **SALES FROM VEHICLES REGULATIONS**

1. These Regulations shall be known and cited as the Town of Channel - Port aux Basques' Sales From Vehicles Regulations.
2. **Interpretations:**
  - (a) "Act" means the Municipalities Act, Chapter M-23 RSN 1990 as amended.
  - (b) "Council" means the Town Council of Channel - Port aux Basques.
  - © "Food" shall be deemed to include materials of all sort which are intended to be or which are capable of being eaten, drunk or absorbed by an organism, whether or not such food is in a raw or prepared state or is intended for such use or consumption and without limiting the generality of the foregoing, shall be deemed to include fish and farm produce and other products whether natural or artificially created.
  - (d) "Goods" shall be deemed to include wares and merchandise of all kinds and sorts intended to be or capable of being sold or exchanged.
  - (e) "Sale", "Sell" and "Selling" shall be deemed to include "Give", "Giving", "Distribute", and "Distribution".
  - (f) "Town" shall mean the Town of Channel - Port aux Basques as defined by Order in Council dated November 1945 and any amendments thereto, according to the Municipalities Act.

- (g) "Vehicle" shall be deemed to include any object in which something can be carried, whether it is capable of self-moving or of being drawn by another vehicle or person, whether or not such object is temporarily or permanently stationary, and, without limiting the foregoing, shall include any rack, stand, frame or other structure.
3. No person shall within the boundaries of the Town of Channel - Port aux Basques use any vehicle or stand for the sale of food or goods without having first obtained a permit from the Council which shall be displayed at the sales location.
4. It is the responsibility of the permit holder to acquire written permission from the property owner, where such property is privately owned, authorizing the use of the property for the conducting of sales.
5. A permit issued hereunder shall be subject to such conditions as Council may prescribe including, without limiting the generality of the foregoing, the following:
- (a) The place or places at which such sales may take place.
  - (b) The times at which such sales may take place.
  - © The types of food and or goods that may be sold.
  - (d) The manner in which goods or wares may be displayed.
  - (e) The types, compositions and dimensions of containers in which such goods or wares may be stored or sold.
  - (f) The manner in which garbage, refuse and other waste items shall be stored and times of which the same must be removed.
  - (g) Times and places at which vehicles used for sales may be removed or parked.
6. Notwithstanding anything else herein provided, any person selling food or goods within the Town or who desires to obtain a permit hereunder shall obtain all other necessary permits and shall comply with all acts and regulations governing such sales whether such permits or regulations or law shall be federal, provincial or municipal in origin.
7. Council may prescribe a fee from time to time for permits issued hereunder.
8. Any person who contravenes any of the provisions of these regulations or fails to comply with any conditions of a permit issued hereunder, is guilty of an offence and liable on summary conviction to a fine not less than \$50.00, and not exceeding \$1,000.00 or in default of payment to a period of imprisonment not exceeding ninety (90) days or to both such fine and period of imprisonment.
9. These regulations shall come into effect on the 1st day of June, 1996 and may be cited as the Town of Channel - Port aux Basques Sales From Vehicles Regulations 1996.
