### SIGN AND SIGNBOARD REGULATIONS

## 1. Interpretations:

In these Regulations, unless the context otherwise requires:

- (a) "Act" means the Municipalities Act, 1979.
- (b) "Council" means the Town Council of the Town of Labrador City.
- (c) "Town" means the Town of Labrador City as defined by Orderin-Council dated the 27th day of June 1961, and any amendments thereto, according to the Municipalities Act.
- (d) "Sign or Signboard" shall indicate every sign, billboard, ground sign, wall sign, roof sign, illuminated sign, projecting sign, or other fixture used to advertise or promote the interest of any person when the same is placed out-ofdoors in view of the general public.
- No person shall erect any sign or signboard within the limits of the Town except with the written permission of the Council.
- 3. Every application for a permit to erect any sign or signboard shall contain or have attached thereto the following information:
  - (1) Name and address of the applicant.
  - (2) Location of building, structure, or lot to which or upon which the sign or signboard is to be erected.
  - (3) Position of the sign or signboard in relation to nearby buildings or structures.

- (4) Plans and specifications indicating description, method of construction, and attachment to the building or in the ground.
- (5) Written consent of the owner of the building, structure, or land to which or upon which the sign or signboard is to be erected.
- (6) Such additional information as the Council deems requisite in any particular case.
- 4. The Council may revoke a permit issued in respect of any sign or signboard whenever there has been a violation of the provisions of these Regulations.
- 5. The Council may, by written notice served upon the owner, order the removal and relocation of any sign or signboard which it considers is unsafe or insecure or is a menace to the public, or has been erected in contravention of these Regulations. If the owner fails to comply with the directions contained in the said notice within ten (10) days after it has been served on him, the Council may cause the removal or relocation of such sign or signboard and may recover the cost of so doing from the owner as a civil debt.
- 6. The owner of every sign or signboard shall be required to have all parts and supports of such sign or signboard properly painted at least once every two years unless the same has been galvanized or otherwise treated to prevent rust.
- 7. No sign or signboard shall be erected, relocated, or maintained as to prevent free ingress to, or egress from, any door, window, or fire escape, and no sign or signboard shall be attached to any standpipe or fire escape.
- 8. No sign or signboard shall be erected at the intersection of any streets in such a manner as to obstruct free and clear vision, or at any location where by reason of its position, shape, or colour, it may interfere with, obstruct the view of, or be confused with any authorized traffic sign, signal, or device.

- 9. Any person who neglects or contravenes any of the provisions of these Regulations is guilty of an offence and shall be liable on summary conviction to a fine not exceeding One Hundred Dollars (\$100.00), or in default of payment to imprisonment for a period not exceeding ninety days, or to both such fine and imprisonment.
- 10. These Regulations were passed and adopted by Council on the 12th day of February 1981, and will come into effect on the 12th day of February 1981, and may be cited as the Town of Labrador City (Sign and Signboard) Regulations, 1981.
