We use AMRS and apply to FCM for Asset Management Funding support for your Town.



Asset Management Plan

Municipalities are eligible for \$50 000 grant from FCM to support Asset Management Plan.

For an Asset Management Plan:

- Municipalities under 1000 residents pay 10%
- Municipalities over 1000 residents pay 20%
- Municipalities over 1000 residents that partner with another municipality pay 10%

Gas Tax Money can be used to fund this plan.





Notes on Asset Management Plan

The federal government will be requiring that all municipalities complete an Asset Management Plan to be eligible for gas tax funding.

Ontario and Alberta require municipalities to have an Asset Management Plan




